Assistant Director Report

Mrs. Alyx Bickel reported on:

- IVVC hosted three days of Sophomore Visits for all ten districts with a total of 658 students completing the registration form. Culinary Arts was the number one first choice program.
- IVVC hosted a CCPE writing workshop on November 11, 2024.
- Mrs. Alyx Bickel had initial meetings with dual credit coordinators from Illinois Valley Community College, Joliet Junior College, and Kishwaukee College to discuss opportunities for students who reside in their respective districts. She will have more information at our February Meeting.

Executive Committee

2025-2026 Calendar Survey

Mr. Joe Barbic reported that he has sent out the survey to all districts, so we can best align our calendar with those of the home schools. The calendar committee of teachers at IVCV will meet for their input once is this completed. Mr. Joe Barbic will then meet with the Executive Committee for feedback. The tentative 2025-2026 calendar will be present for approval at the February 5, 2025 Board meeting.

Work Based Learning

- We have five Auto Tech, five Construction Trades, Second Year Sport Medicine, and Teaching Method students on internship.
- Certified Nursing Assistant students are in clinicals currently.
- We will have students from Computer Tech and Programming working the Technology Help Desk at Fox Valley Senior Center.
- Emergency Medical Services will begin clinicals and Culinary Arts will be starting internships in January.
- The Human/Public Service Career Breakfast was held on November 7, 2024 with eighty students registered and nineteen Health Care Professionals participated.

State and Federal Grant Updates

Perkins Funding - IVVC has an allocation of \$81,572 for 2024-2025. \$15,019 has been received to date.

CTEI - IVVC has an allocation of \$500,920 for 2024-2025. \$100,184 has been received to date.

Construction Trades

The students have been working on the 2901 Ernest Drive house which is moving along well. Currently, we have 90% of the roof sheeted and the basement was poured on November 26, 2024. The windows have arrived and will be installed once the roof underlayment is completed. Mr. Joe Barbic explained that he was approached by a family who would like IVVC to build their house next year. After his meeting with the family, he recommends not to move forward with this project next year.

EV Grant

Mr. Joe Barbic explained that he was able to apply for the Clean Energy Career Pathway Grant that is available through a collaboration of the Illinois Department of Commerce and Economic Opportunity and the Illinois State Board of Education. The focus of this grant is the exposure of electric vehicles and career pathways for students especially in the rural communities. The grant request was for \$475,411.
